

Notice regarding the FY 2024 Hino City Priority Support Benefit as Measures to Cope with Price Increases (additional benefit for child-rearing households)

This benefit is provided under an additional benefit program to support child-rearing households that include **children**^{*2} among the households eligible for the **Priority Support Benefit**^{*1}.

Priority Support Benefit^{*1}

Hino City Priority Support Benefit as Measures to Cope with Price Increases (benefits for tax-exempt households: 30,000 yen/household)

Children^{*2}

Children born between April 2, 2006 and July 31, 2025 residing in Japan

Benefit amount

20,000 yen per child

Payment period

In the case of application, approximately 3 to 4 weeks after the date the city accepts the application.

* Except for cases when there is any deficiency in the documents, etc.

Benefit recipients and whether or not the application was made

Reference date December 13, 2024

Households eligible for benefits

Households that have received the “Priority Support Benefit^{*1}” from Hino City

Households that are eligible for the “Priority Support Benefit^{*1}” but have not received it yet

Among households that have received the Priority Support Benefit^{*1} from Hino City, the head of a household that includes children^{*2} as household members as of the reference date will receive a “Payment Notification” (no procedure required in principle).

* There are some cases in which it is necessary to make application.

Application is required.

Application period: From Friday, February 21, 2025 to Thursday, July 31, 2025

Heads of households who are registered as local citizens of Hino City as of a reference date (excluding victims of domestic violence) can apply. Application forms can be downloaded from Hino city's official website, or are available at Hino City Safety Net Call Center or the city's reception desk on the 2nd floor of the City Hall.

Payment procedures

① Households that **have received** “Priority Support Benefit^{*1}” from Hino City (**no application required in principle**)

- In principle, for households that have already received the benefit, the benefit money will be transferred to their Priority Support Benefit account without any procedures.
- A payment decision notification will be sent to such households prior to the payment. Please note that the “benefit amount” set forth in the notification is based on the number of children in the same household as of the reference date, December 13, 2024.
- ^{*}In the case that your household did not include children^{*2} as of the reference date but has children^{*2} who were born by July 31, 2025, or that you are supporting children^{*2} in a separate household, it is necessary to make application. (The application method is the same as ②)



② Households eligible for the “Priority Support Benefit^{*1}” but **have not received it yet** (**application is required**).

- Households that include children^{*2} as household members (including children^{*2} born on or after the day after the reference day) among the households that are eligible for the “Priority Support Benefit^{*1}” but have not yet received it
- Households supporting children^{*2} who live in a different household in Japan (excluding those whose children^{*2} are eligible for benefits in another city, ward, town, or village)
- Victims of domestic violence from outside the city, etc.
- **Application is required** to receive the benefit.

^{*} Application forms can be downloaded from Hino city's official website, or are available at the city's reception desk (get off the elevator at the east side of the main building on the 2nd floor and go left).



- Please fill in the required items on the application form and submit it along with the attached documents to the city's reception desk in person or by mail.

^{*} **For both 1 and 2, households who are registered as local citizens somewhere in Japan as of January 1, 2024**
