- The FY 2024 Hino City Priority Support Benefit as Measures to Cope with Price Increases (for tax-exempt households) is an additional grant project to support households that are exempted from the per-capita amount of inhabitant tax for FY 2024 in order support people affected by price increase.
- It is required to carry out confirmation or <u>take necessary procedures</u> to receive the benefit.

### Eligibility for benefits and whether or not to apply Reference date December 13, 2024

Households eligible for benefits

Households consisting only of individuals who are exempt from the per-capita individual inhabitant tax for FY 2024 Tax-exempt households including those who moved into the city on or after January 2, 2024 (moving in, domestic violence, undeclared, etc.)

A "Payment Notification" (no procedure required) or a "Confirmation Letter" (procedure required) will be sent out in sequence. There are some cases in which it is necessary to make application.

# Application period: From Friday, February 21, 2025 to Wednesday, April 30, 2025

Heads of households who are registered as residents of Hino City as of a reference date (excluding victims of domestic violence) can apply. Application forms can be downloaded from Hino city's official website, or are available at Hino City Safety Net Call Center, Hino City Social Welfare Council, Satellite Center of *Miraito*, Living Independence Consultation and Support Desk, etc.

## **Payment procedures**

### 1 Households consisting only of individuals who are exempt from the per-capita individual inhabitant tax for FY 2024

#### Households eligible for receiving a "Payment Notification"

Among the tax-exempt households that have been registered as local citizens of Hino City since January 1, 2024, or before that, households that have received similar benefits from the city in the past, or whose information on a bank or savings account to receive various benefits is known to the city

- Eligible households will receive a "Payment Notification" describing benefit details and confirmation items from the city.
- Check its contents, and if you have neither changed your transfer account, nor refused to receive the benefit, please wait. The benefit will be transferred to the account written in the notification. [Confirmation items]
  - ① If the transfer account for the benefit is written, make sure there are no errors or items to be changed.
  - ② If you wish to change your transfer account or refuse to receive the benefit, please contact the call center by the contact deadline.

#### Households eligible for receiving a "Confirmation Letter" Among the tax-exempt households that have been registered as local citizens of Hino City since January 1, 2024, or before that, eligible households other than those applying to the description above

- Eligible households will receive a "Confirmation Letter" describing benefit details and confirmation items from the city.
  - After checking the contents of the "Confirmation Letter," fill out and return it to the city.
    - \* You can also submit the letter online or bring it to the reception desk on the east side of the second floor of City Hall. [Confirmation items]



① The account verification document (copy)

\* which must list the bank, branch, account number, and account holder name in kana is required.

② Make sure if there is anyone in the household who has income that is subject to inhabitant tax.

# 2 First payment from Hino City (30,000 yen) Tax-exempt households with no recipient (moving in, domestic violence, undeclared, etc.) Application is required.

Those who moved in on or after January 2, 2024 (including those who moved in as part of a household), households that are recognized as exempt from taxation based on declarations, etc., households who failed to submit a notification of moving in within 14 days from the move-in day as set forth in the Act of the Basic Resident Registers, and registered their residency in Hino City before the reference date, and victims of domestic violence from outside the city


- Application is required to receive the benefit.
  - \* Application forms can be downloaded from Hino city's official website, or are available at the city's reception desk (get off the elevator on the east side of the main building on the 2nd floor and go left).
- Please fill in the required items on the application form and submit it along with the attached documents to the city's reception desk in person or by mail.

\* For both 1 and 2, households who are registered as local citizens somewhere in Japan as of January 1, 2024
